No. 856 dated 12/03/2018

Concerning the Amendment of the Internal Bylaws of the Faculties of Agriculture of the Universities

(Cairo - Alexandria (El-Shatby)- Zagazig and Damanhour Universities)

The Minister of Higher Education and Scientific Research and the President of the Supreme Council of Universities:

** Having reviewed the law no. 49/1972 concerning the organization of universities and its amendments,

** the Presidential decree no. 809/1975 concerning the issuing of the executive regulation of the Universities' organization law and its amendments,

** the Ministerial Decree no. 2167 dated 16/08/2009 concerning the issuing of the internal bylaws of the Faculty of Agriculture – Cairo University (postgraduate studies program) based on the credit hour system and its amendments,

** the Ministerial Decree no. 779 dated 14/04/2011 concerning the issuing of the internal bylaws of the Faculty of Agriculture (El-Shatby)– Alexandria University (postgraduate studies program) based on the credit hour system and its amendments,

** the Ministerial Decree no. 1433 dated 16/12/1990 concerning the issuing of the internal bylaws of the Faculty of Agriculture – Zagazig University (post-graduate studies program) based on the credit hour system and its amendments,

** the Ministerial Decree no. 2584 dated 19/09/2007 concerning the issuing of the internal bylaws of the Faculty of Agriculture Damanhour University (postgraduate studies program) based on the credit hour system and its amendments,

** the approval of Cairo University Council on 26/07/2017,

** the commissioned approval of the President of the University of Alexandria on 28/04/2012 and 24/01/2017,

** the approval of the Council of Zagazig University meeting on 25/07/2017 extended until 31/07/2017,

** the approval of the Council of Damanhour University on 30/08/2017,

** the approval of the Committee of the Agriculture Sector Studies on 16/09/2017, 28/10/2017,

** and the approval of the Higher Council of the Universities on 16/12/2017.

Has decided

(Article 1)

In addition to the manuscripts of the articles specifying the awarding of the scientific degrees endorsed in the internal bylaws of the Faculties of Agriculture of the Universities (Cairo – Alexandria (El-Shatby) - Zagazig - Damanhour), the awarding of a unified joint Master degree in the field of Sustainable Land Management using the European Credit Transfer System (ECTS) and its equivalence in local credit hours within the framework of a joint-project with some European Universities financed by the European Union to support the higher education system.

(Article 2)

To be added to the internal bylaws of the above-mentioned Faculties of Agriculture of the Universities (Cairo - Alexandria (El-Shatby) - Zagazig - Damanhour), the internal bylaws of the unified joint master degree in the field of Sustainable Land Management using the European Credit Transfer System (ECTS) and its equivalence in local credit hours within the framework of a joint-project with some European Universities financed by the European Union to support the higher education system.
